## Low-ohmic single-pole single-throw analog switch

Product data sheet

### 1. General description

---

The NX3L1G384 is a low-ohmic single-pole single-throw analog switch. It has two input/output terminals (Y and Z) and an active LOW enable input pin ( $\bar{E}$ ). When  $\bar{E}$  is HIGH, the analog switch is turned off.

Schmitt trigger action at the enable input ( $\bar{E}$ ) makes the circuit tolerant to slower input rise and fall times. The NX3L1G384 allows signals with amplitude up to  $V_{CC}$  to be transmitted from Y to Z; or from Z to Y. Its low ON resistance ( $0.5\ \Omega$ ) and flatness ( $0.13\ \Omega$ ) ensures minimal attenuation and distortion of transmitted signals.

Fig 1. Logic symbol



Fig 2. Logic diagram



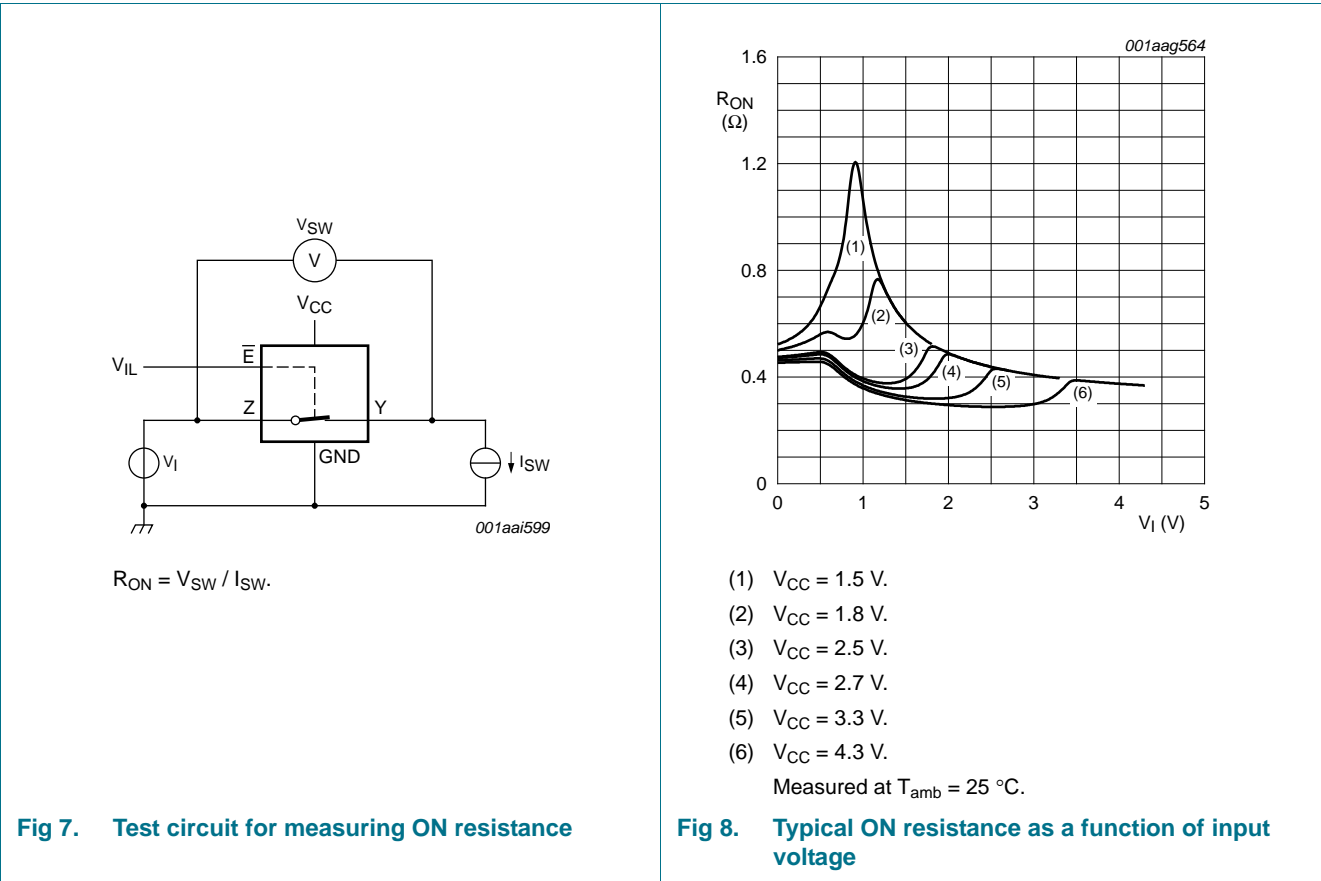

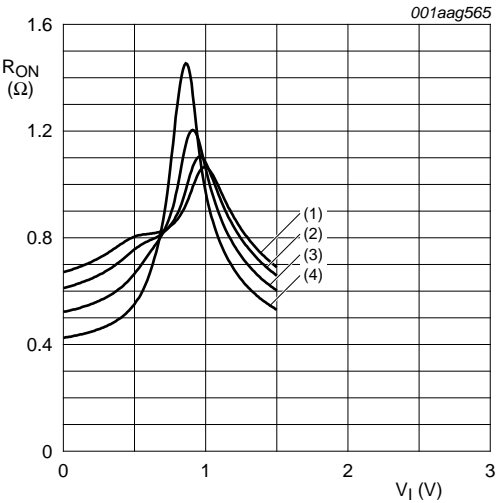

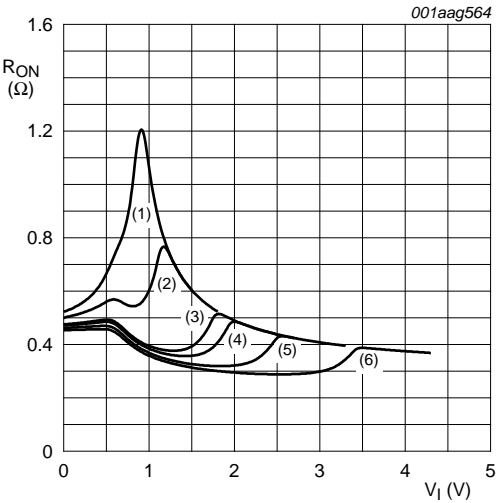

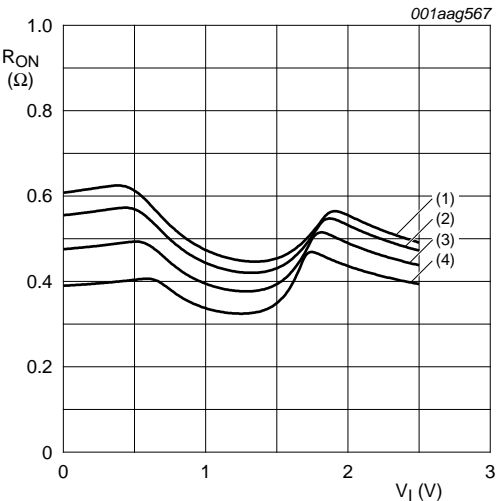

 $V_{CC} = 1.5\text{ V}$



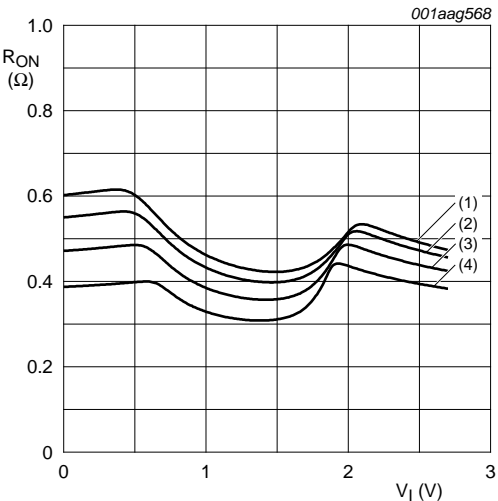

 $V_{CC} = 1.8\text{ V}$



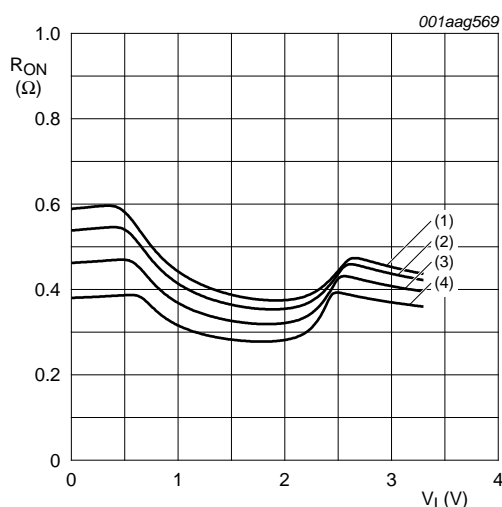

 $V_{CC} = 2.5\text{ V}$



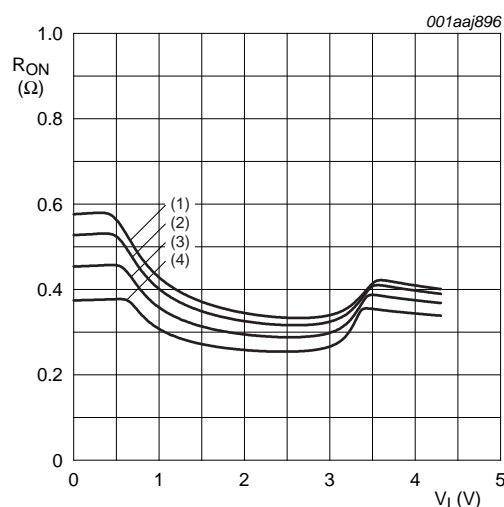

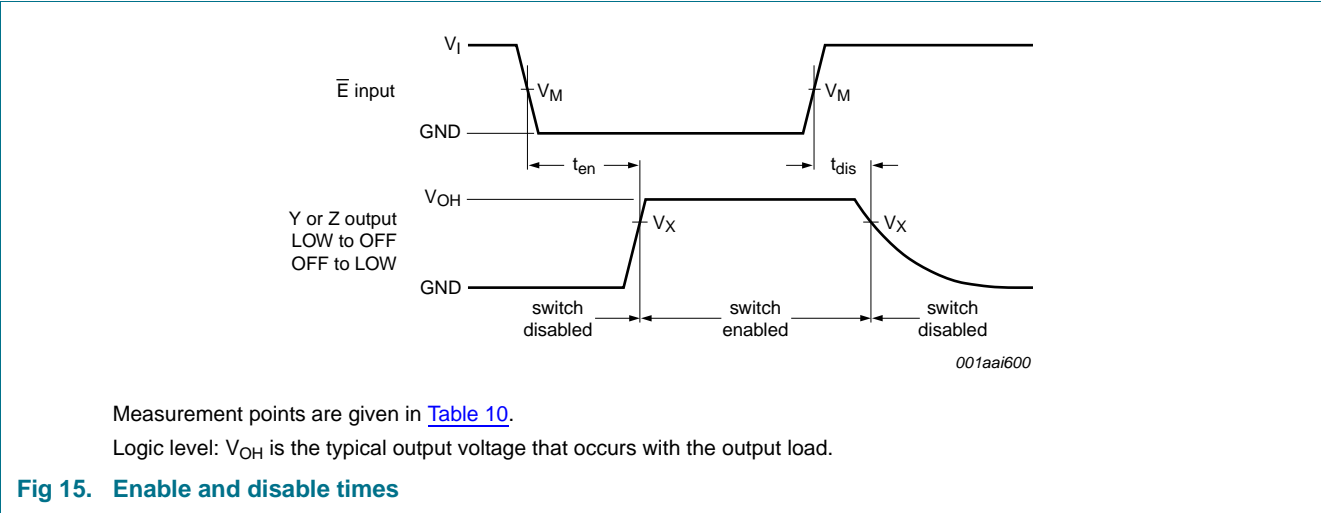

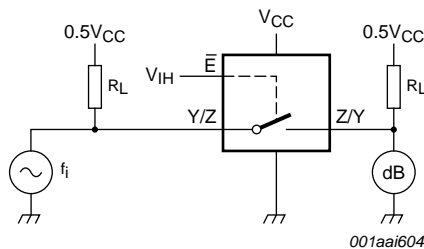

**Fig 17. Test circuit for measuring total harmonic distortion**



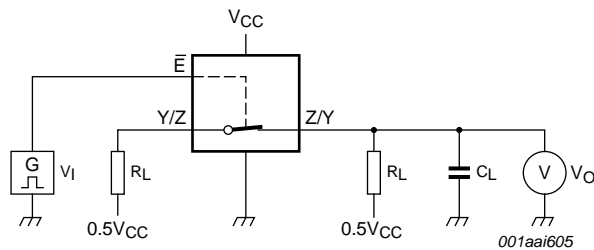

Fig 18. Test circuit for measuring the frequency response when channel is in ON-state

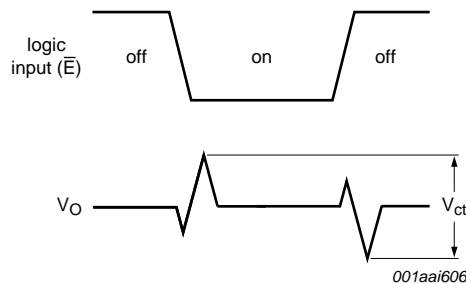


Adjust  $f_i$  voltage to obtain 0 dBm level at input.

Fig 19. Test circuit for measuring isolation (OFF-state)

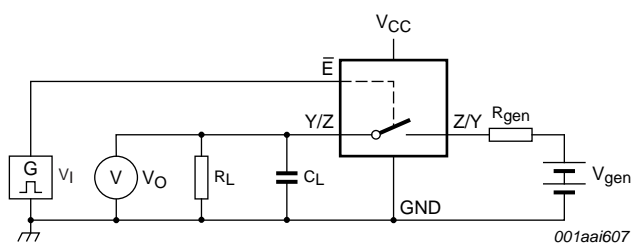


a. Test circuit

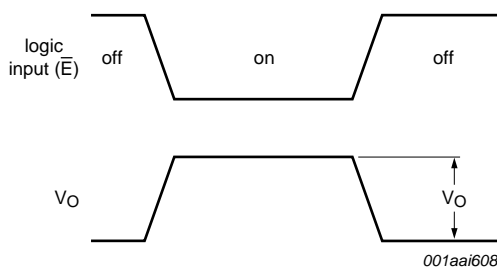


b. Input and output pulse definitions

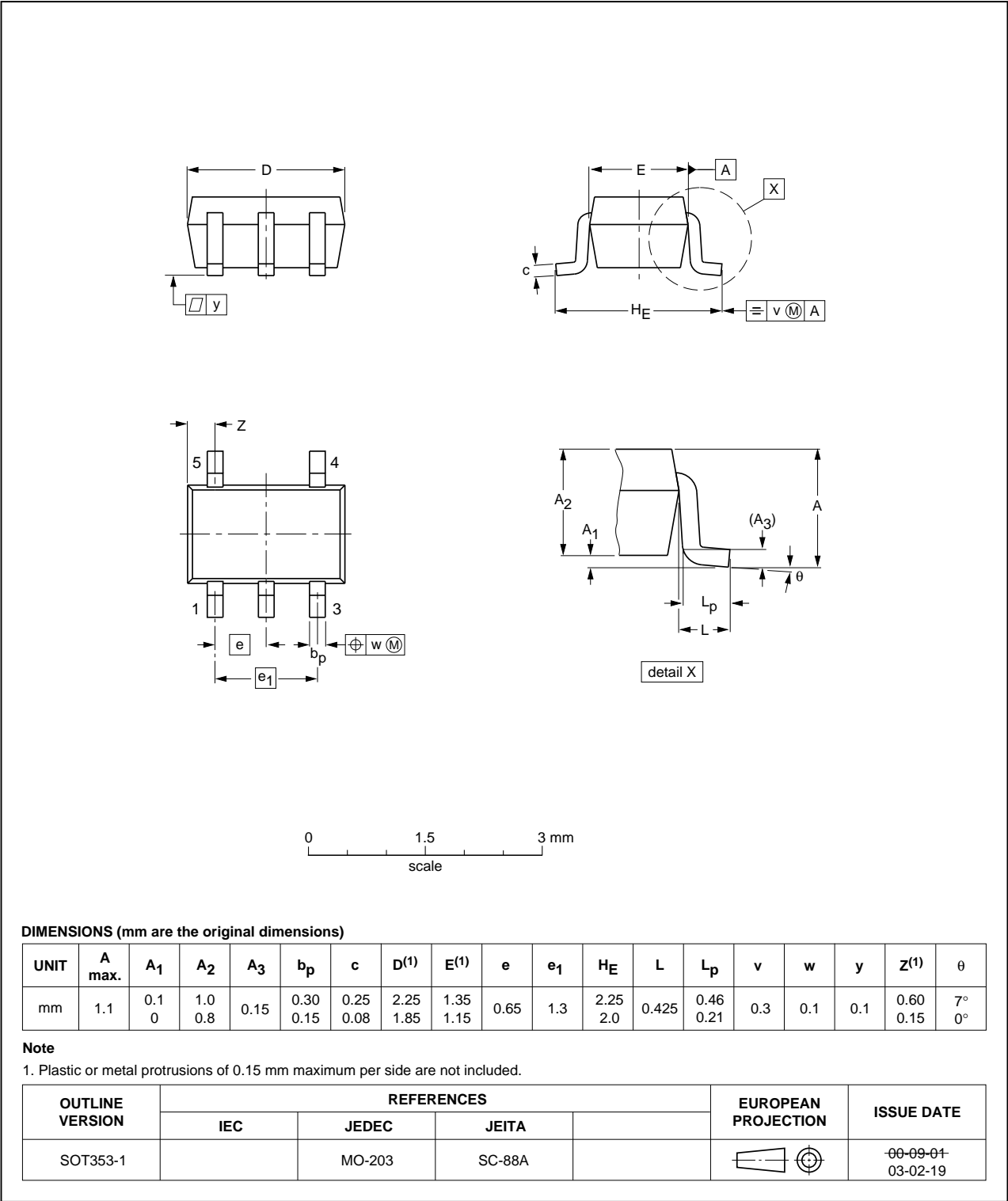


Fig 22. Package outline SOT353-1 (TSSOP5)

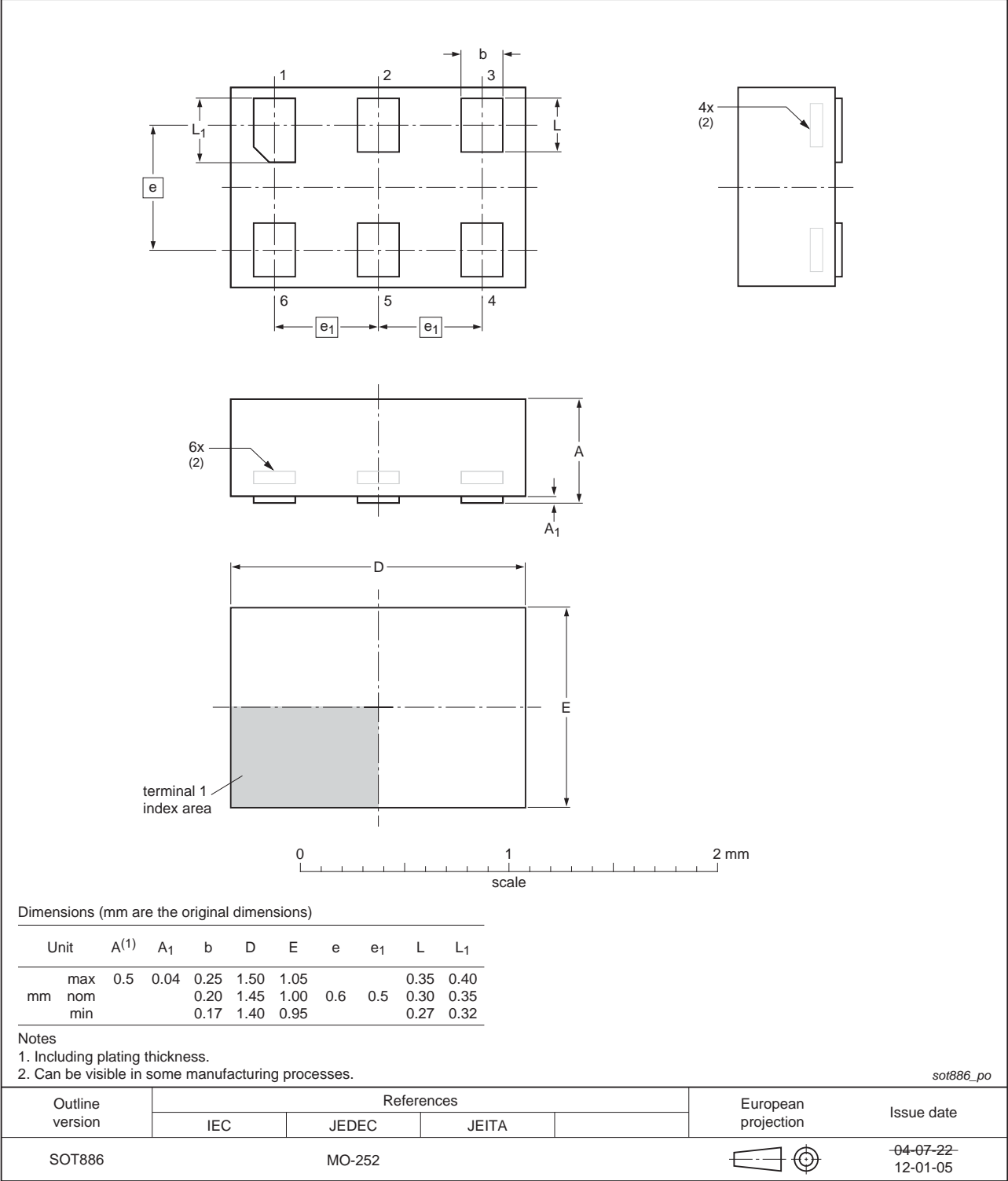


Fig 23. Package outline SOT886 (XSON6)
