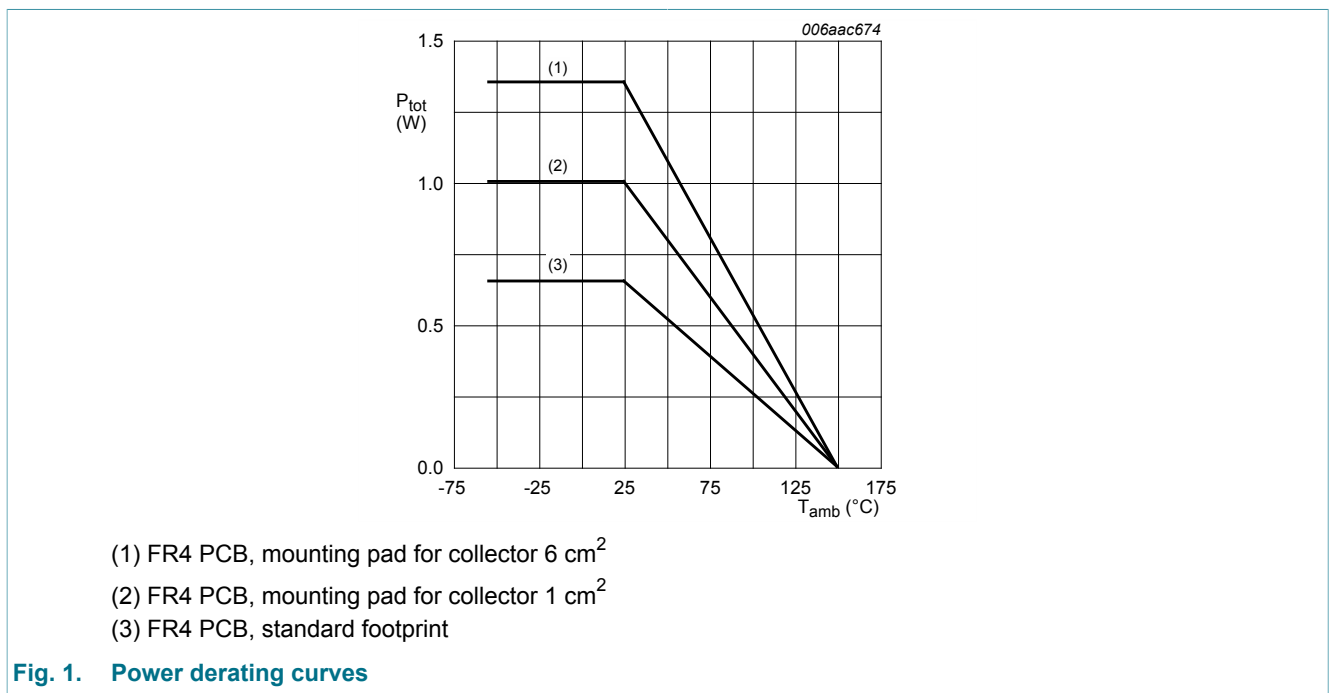


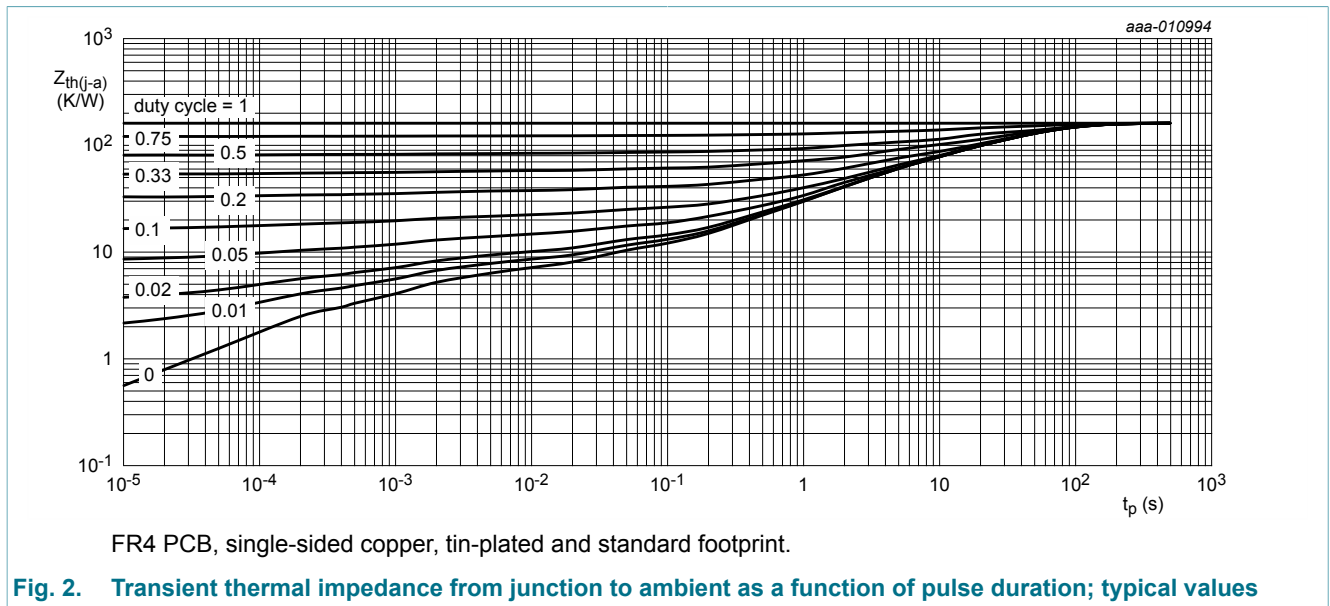
Fig. 1. Power derating curves

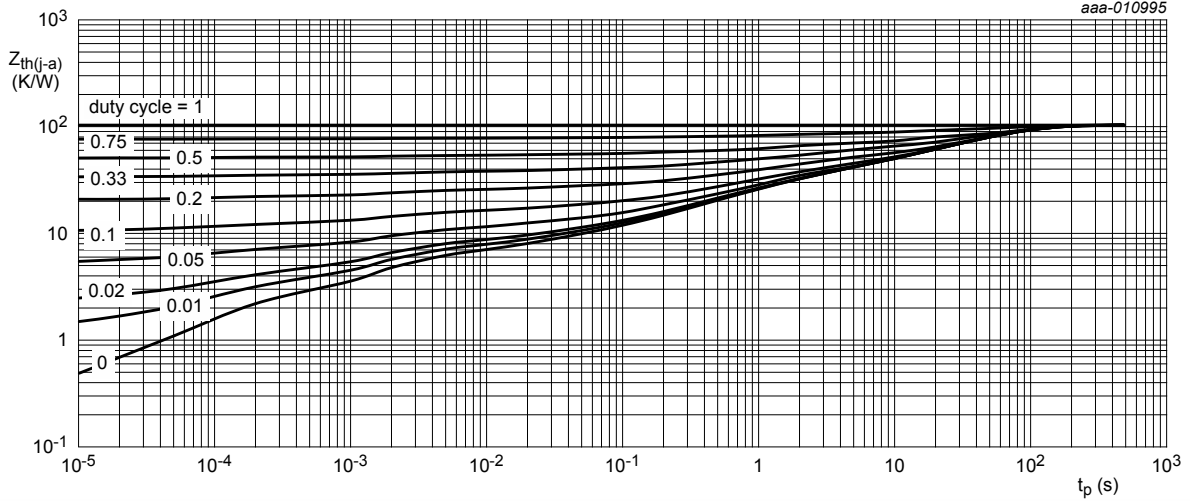


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

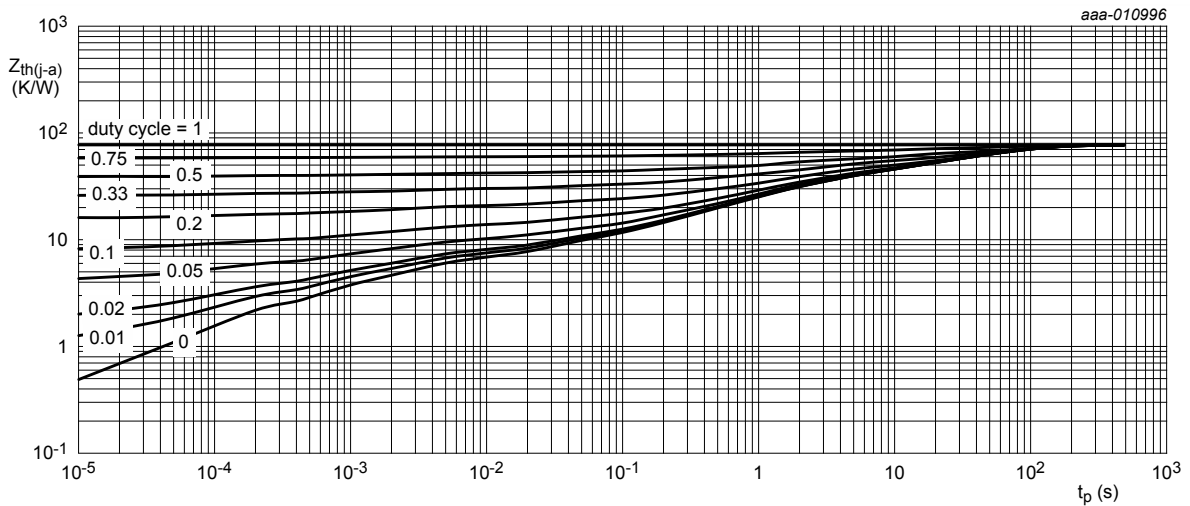
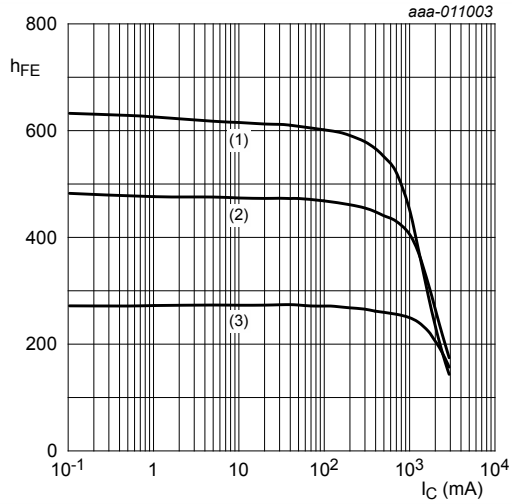


Fig. 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

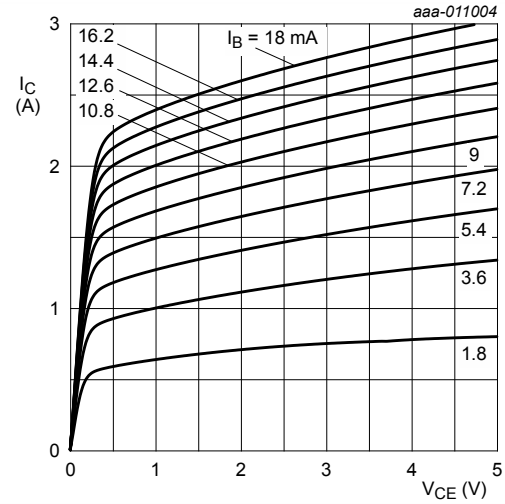

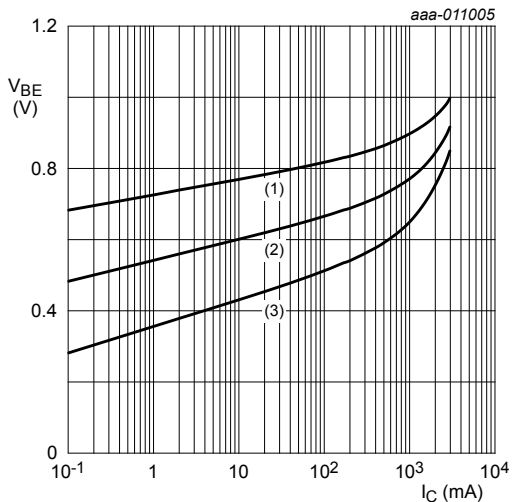

Fig. 6. Collector current as a function of collector-emitter voltage; typical values



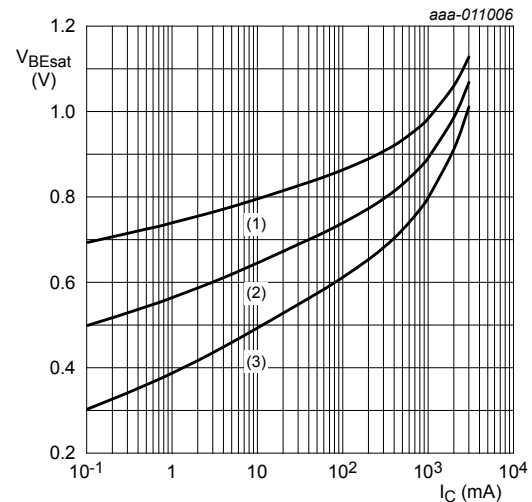

Fig. 7. Base-emitter voltage as a function of collector current; typical values



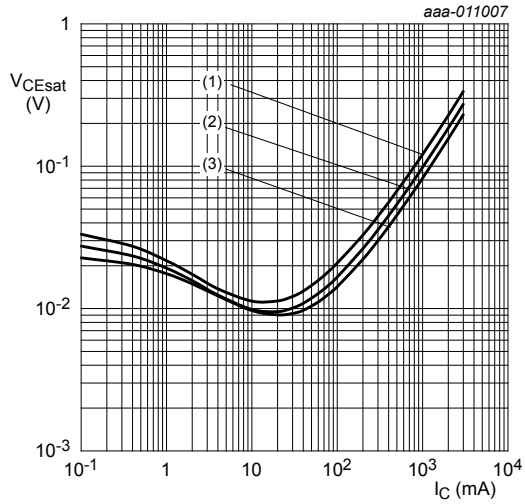

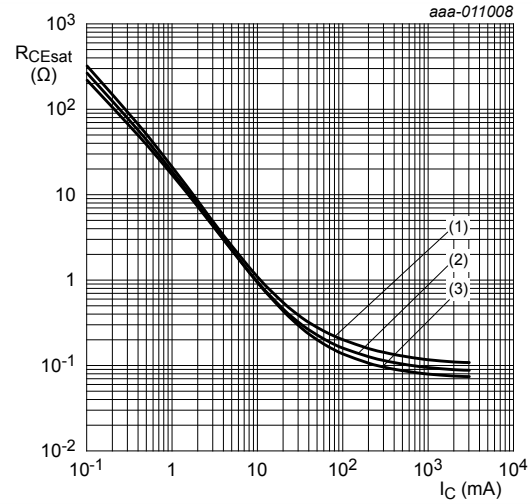
Fig. 8. Base-emitter saturation voltage as a function of collector current; typical values

**Fig. 10. Collector-emitter saturation resistance as a function of collector current; typical values**

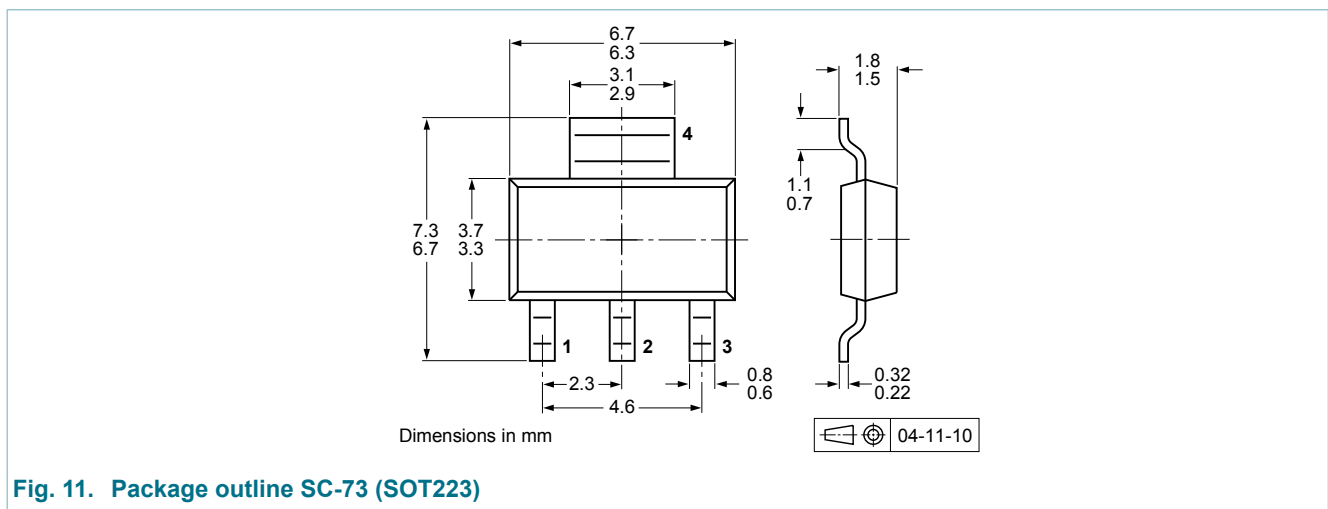

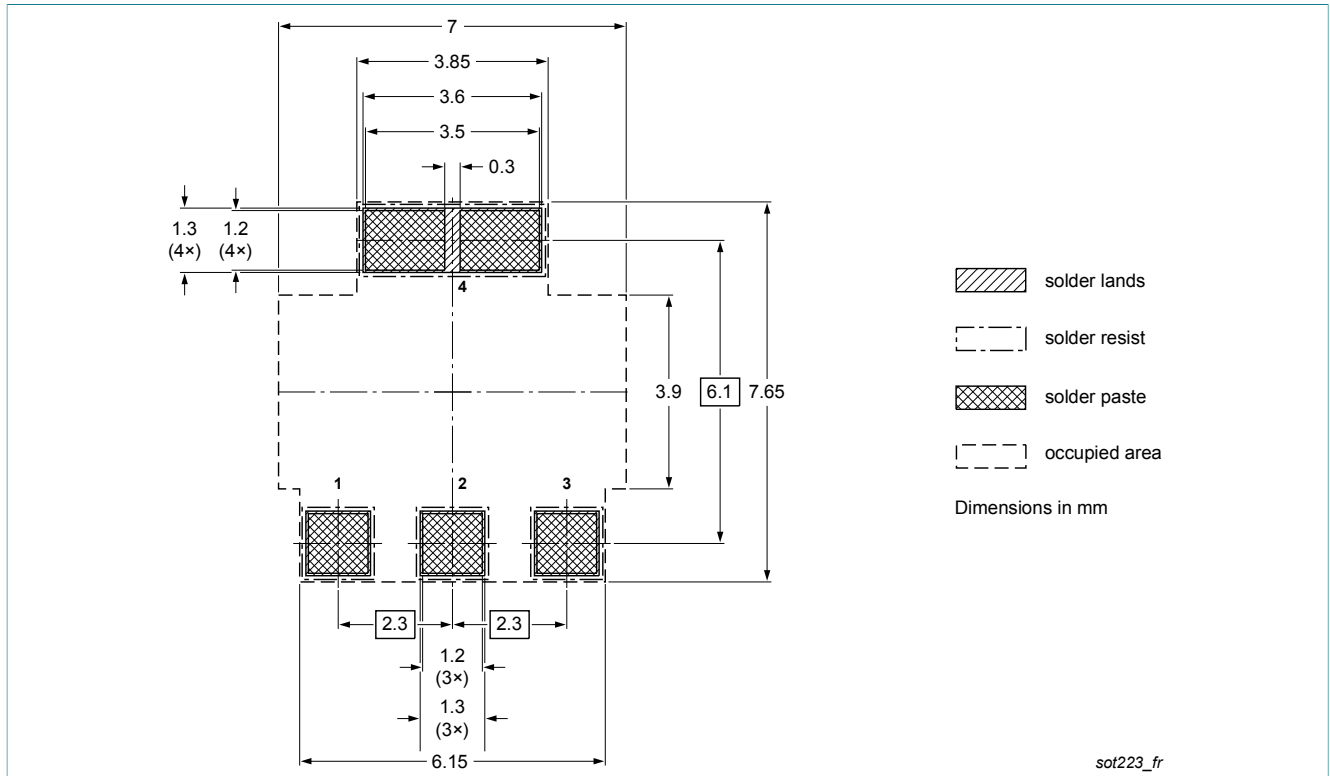


Fig. 12. Reflow soldering footprint for SC-73 (SOT223)

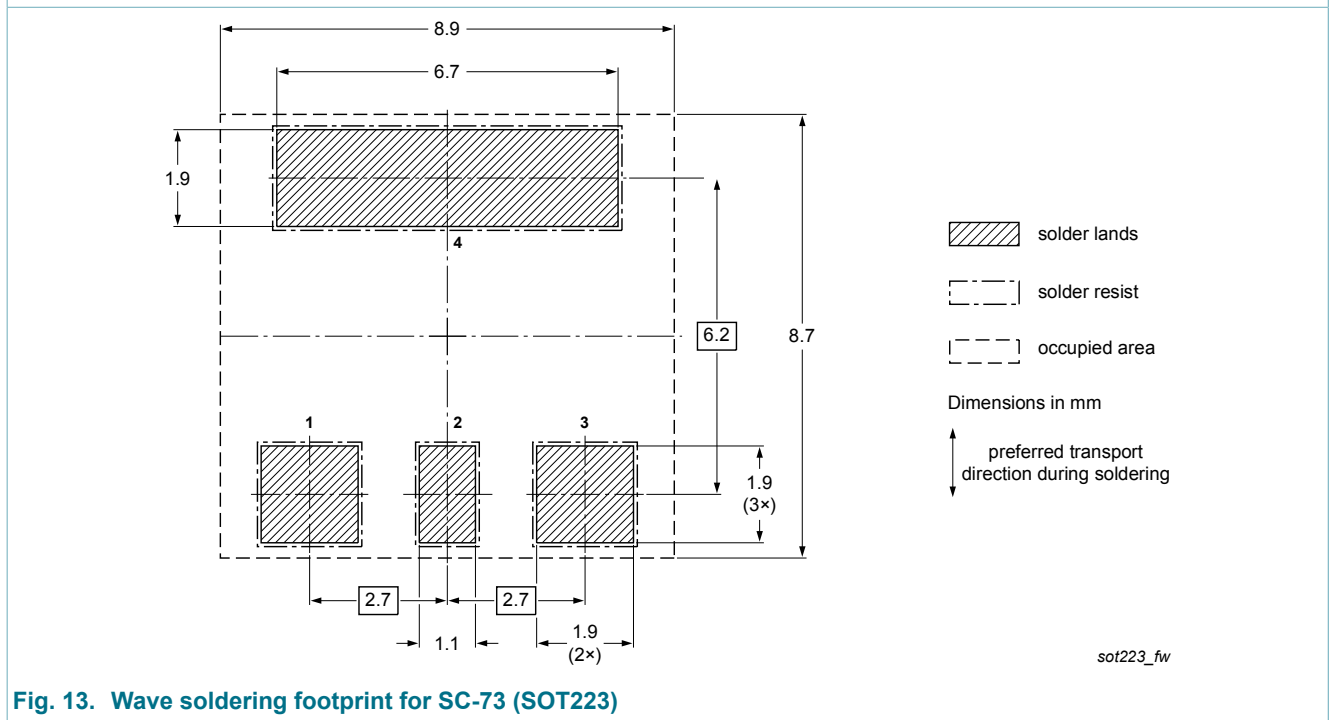


Fig. 13. Wave soldering footprint for SC-73 (SOT223)
