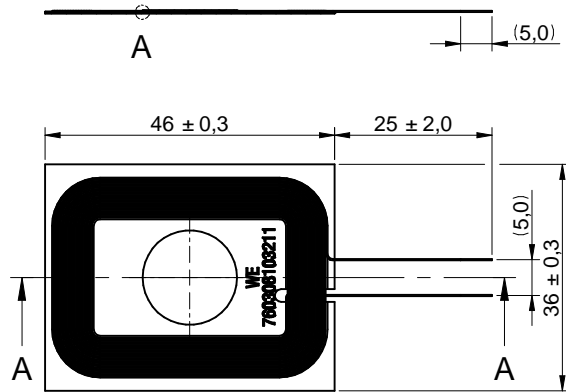
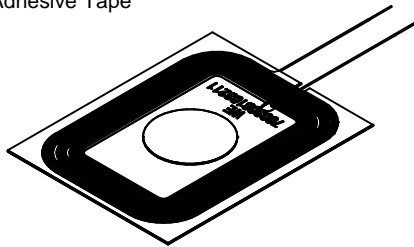
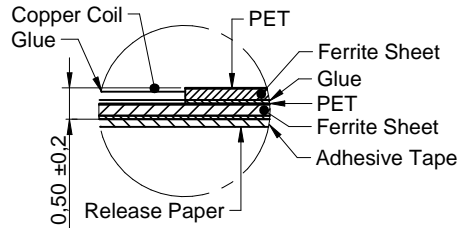

sectional drawing A-A

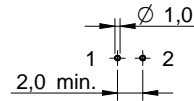

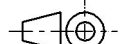

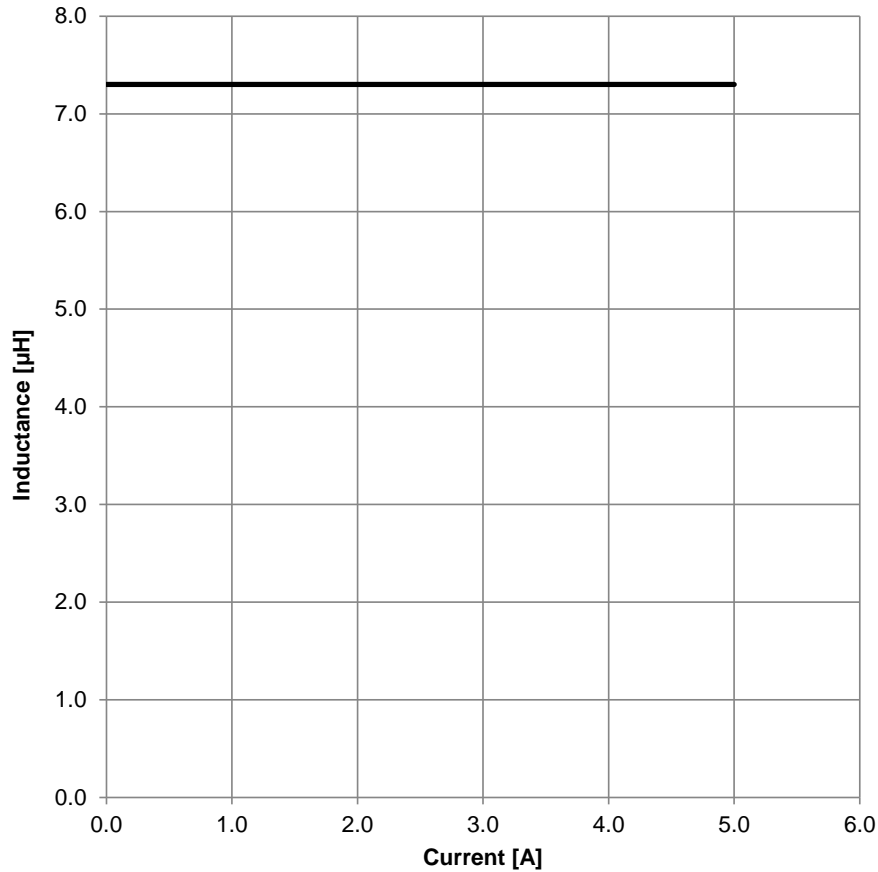

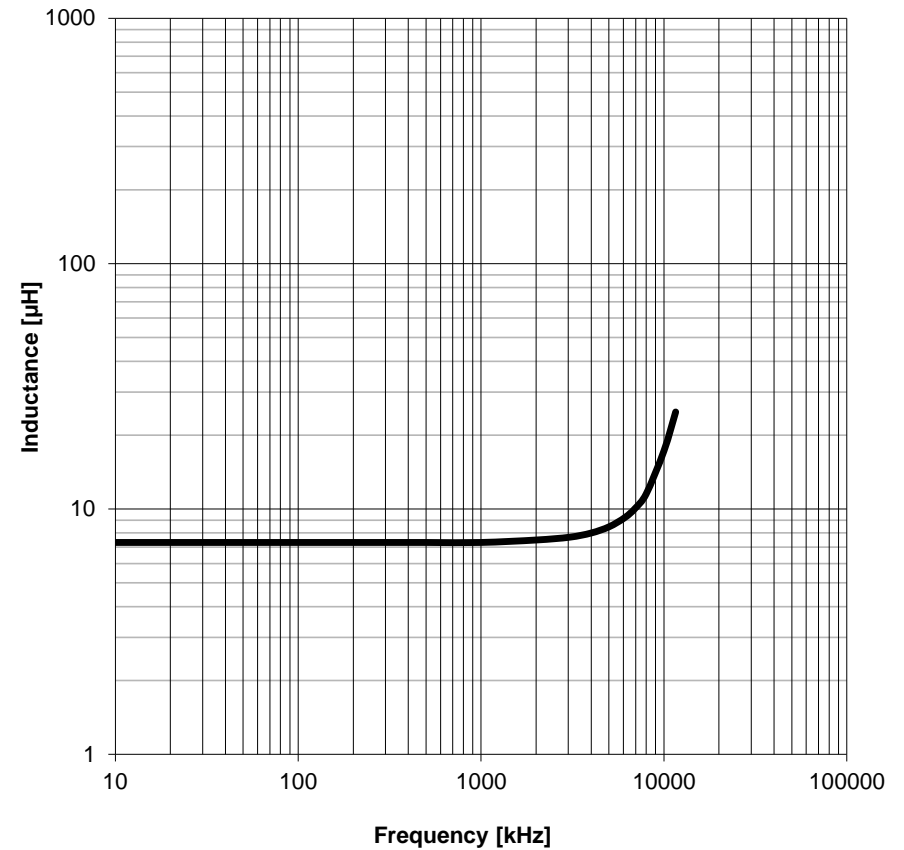

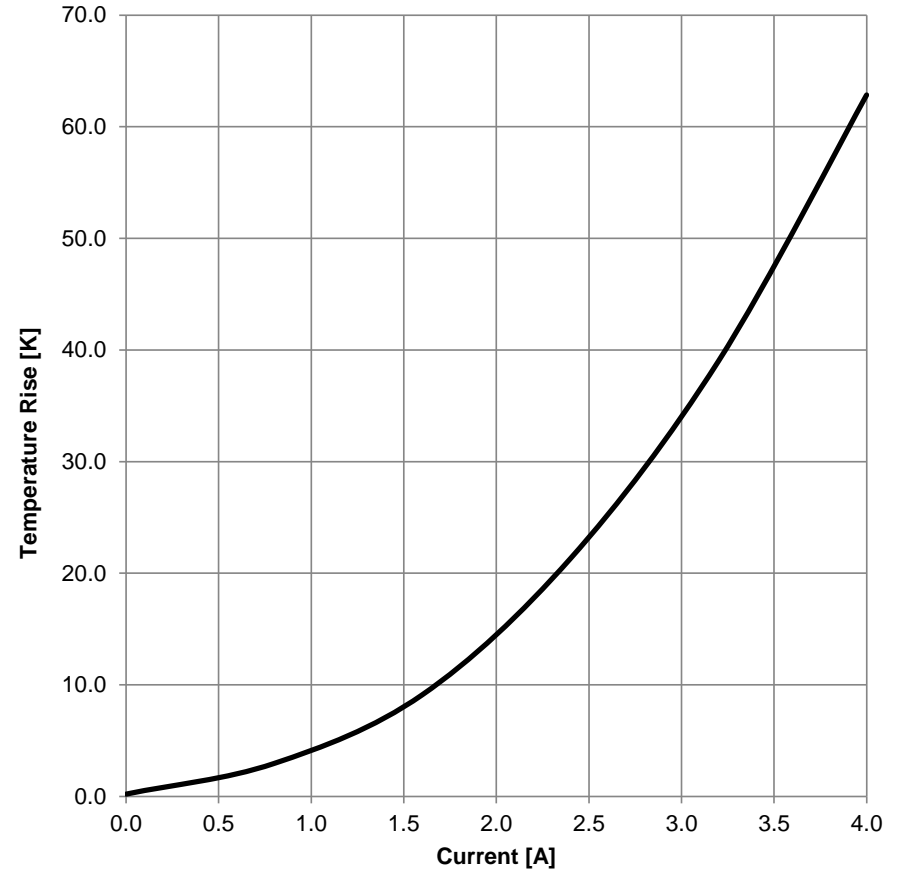

Typical Temperature Rise vs. Current Characteristics:






