




Fig. 1 - Maximum Forward Current Derating Curve




Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current





Fig. 3 - Typical Instantaneous Forward Characteristics

Fig. 6 - Typical Reverse Leakage Characteristics




Fig. 4 - Typical Reverse Leakage Characteristics




Fig. 7 - Typical Junction Capacitance




Fig. 5 - Typical Instantaneous Forward Characteristics





Fig. 8 - Typical Transient Thermal Impedance
