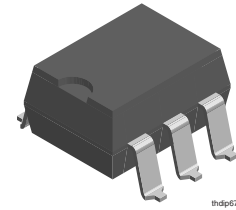
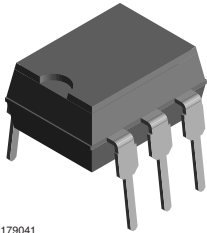


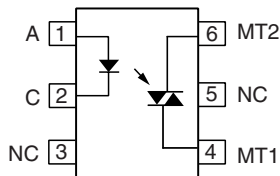

DESCRIPTION

The VO3052/VO3053 triac driver family consists of a GaAs infrared LED optically coupled to a monolithic photosensitive non zero crossing triac detector chip.

The 600 V blocking voltage permits control of off-line voltages up to 240 VAC, with a safety factor or more than two, and is sufficient for as much as 380 V.

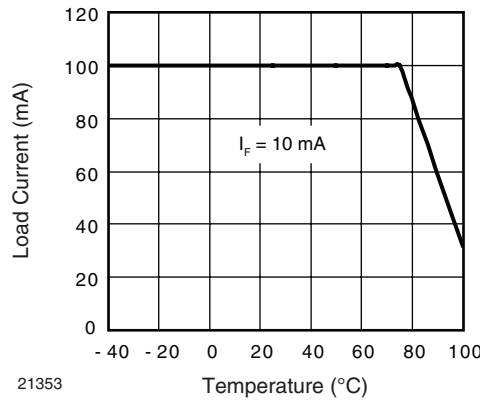


Fig. 1 - On-State Current (RMS) vs. Temperature

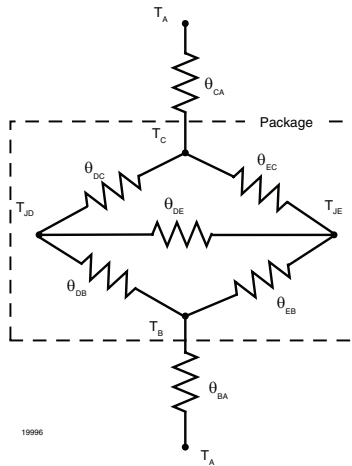

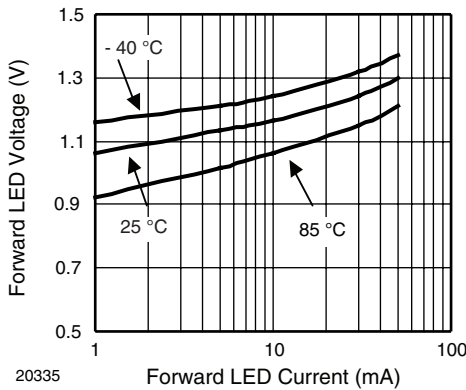


Fig. 2 - Forward Voltage vs. Forward Current

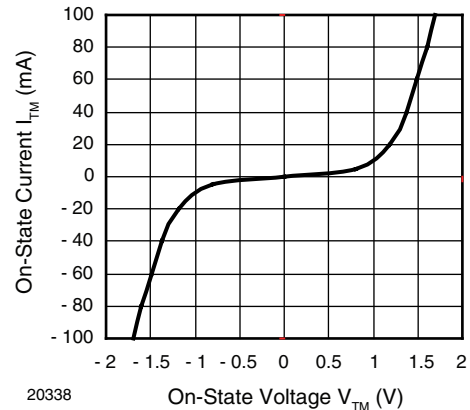


Fig. 4 - On-State Current vs. V_{TM}

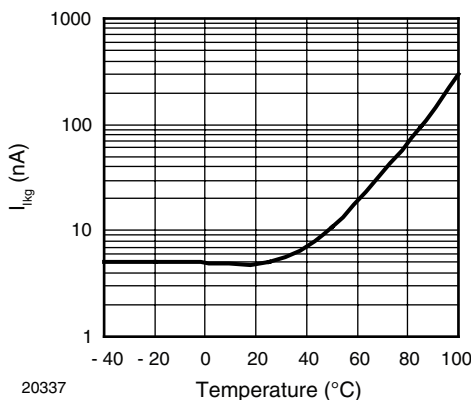


Fig. 3 - Off-State Leakage Current vs. Temperature

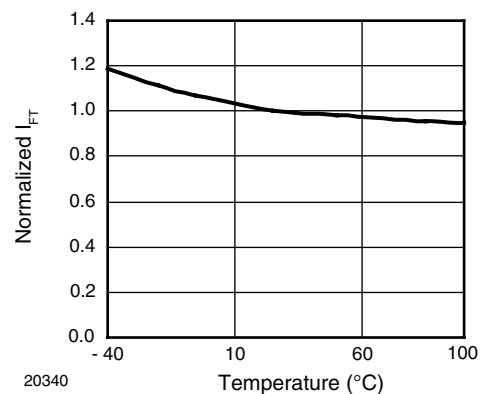
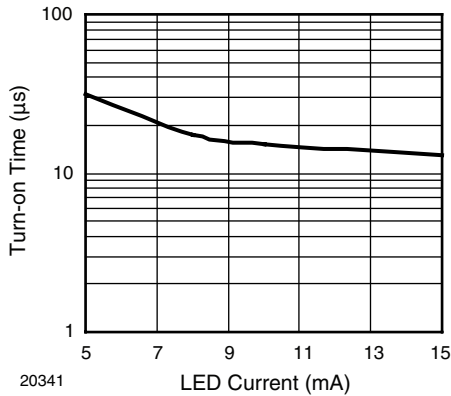


Fig. 5 - Normalized Trigger Current vs. Temperature

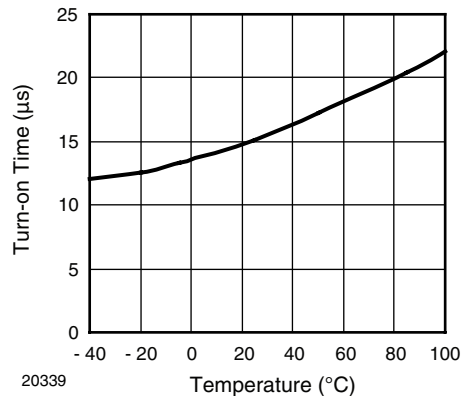

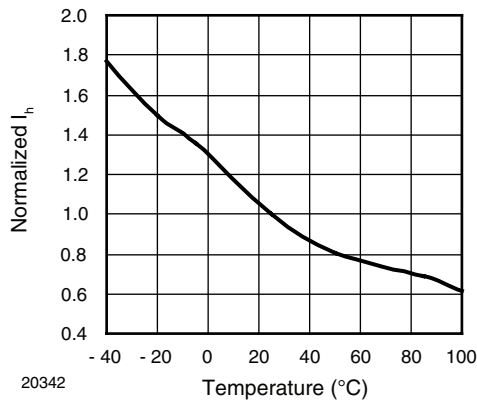

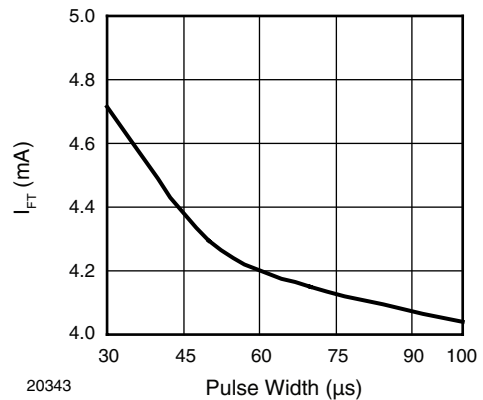
20341 Fig. 6 - Turn-on Time vs. LED Current



20339 Fig. 8 - Turn-on Time vs. Temperature

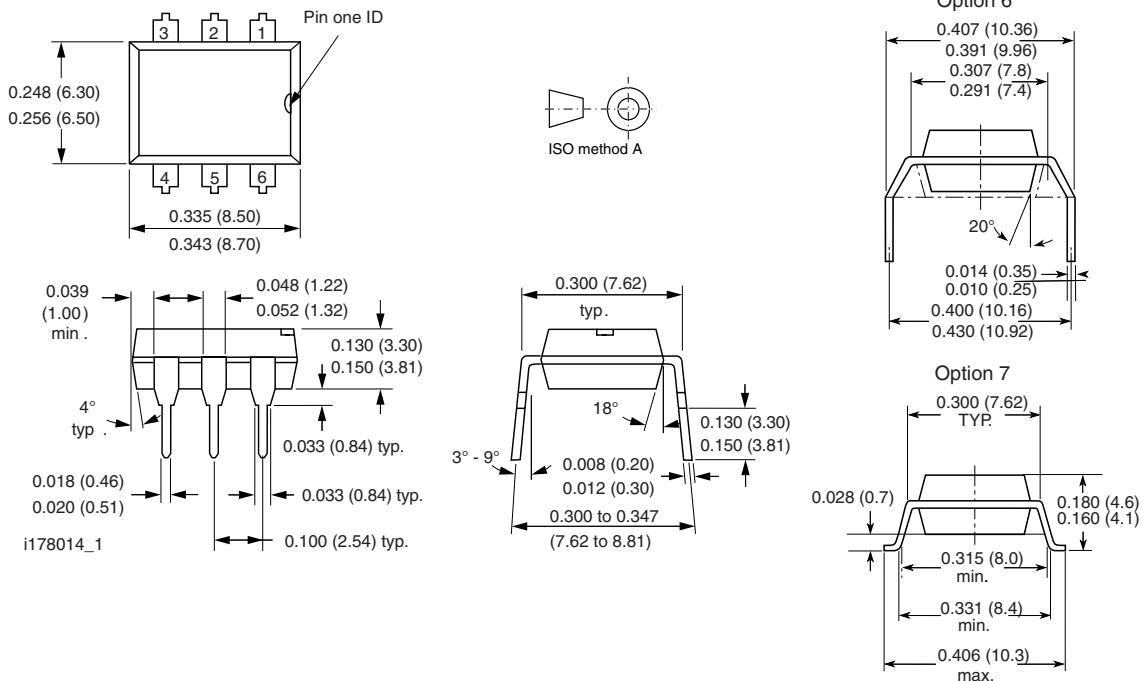


20342 Fig. 7 - Normalized Holding Current vs. Temperature
