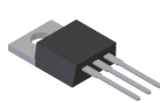

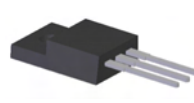

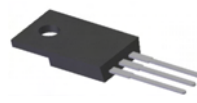

Top View



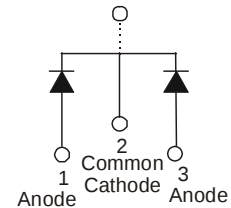
TO-220AB
