F3 Forward Current vs. Forward Voltage:




F4 Luminous Intensity vs. Forward Current:





F5 Junction temperature vs. Dominant Wavelength:




F6 Junction temperature vs. Luminous Intensity:





F7 Derating Curve:





The bin is defined on intensity, chromaticity coordinate or wavelength and forward voltage. In order to ensure highest availability, the reel binning of standard deliveries can vary. A single bin cannot be ordered. Please contact us in advance, if you need a particular bin sorting before placing your order to clarify the lead time, MOQ and pricing.



Product specific:

Follow all instructions mentioned in the data sheet, especially:

- The soldering profile has to be complied with according to the technical reflow/ or wave soldering specification, otherwise this will void the
