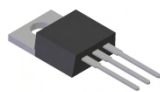

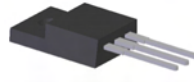

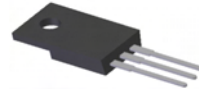
TO-220AB  
Top View



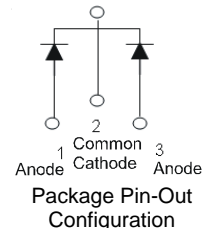
TO-220AB

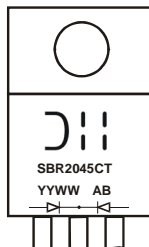

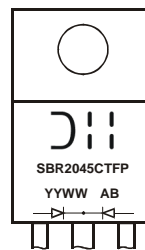

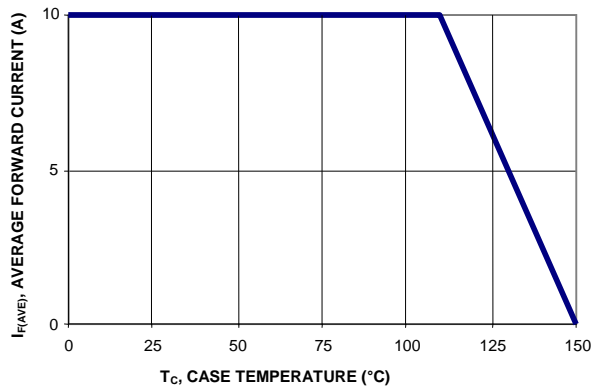


Figure 1: Current Derating Curve, Per Element

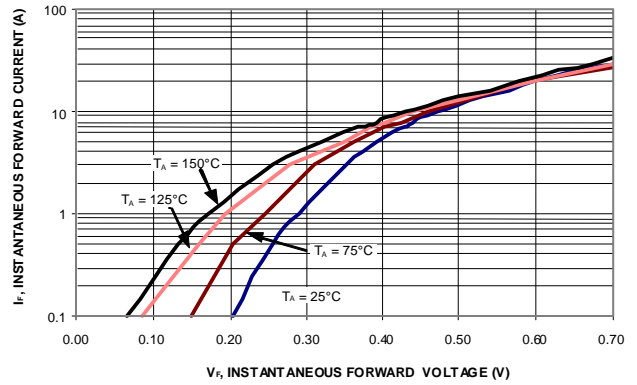


Figure 2: Typical Forward Characteristics, Per Element

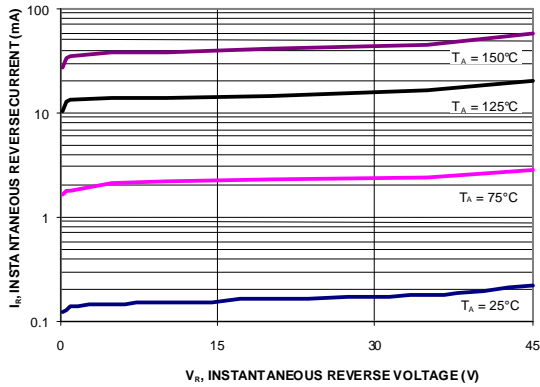


Figure 3: Typical Reverse Characteristics, Per Element

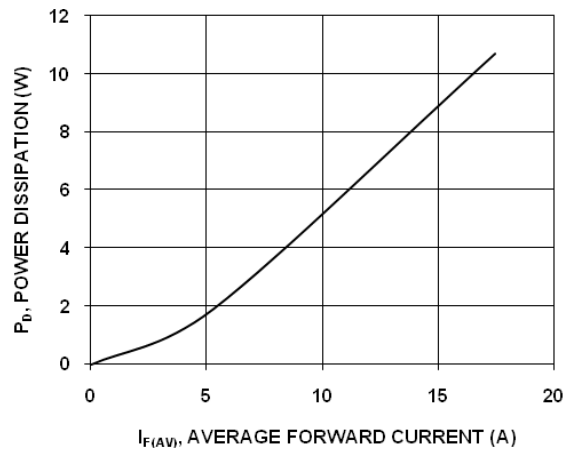
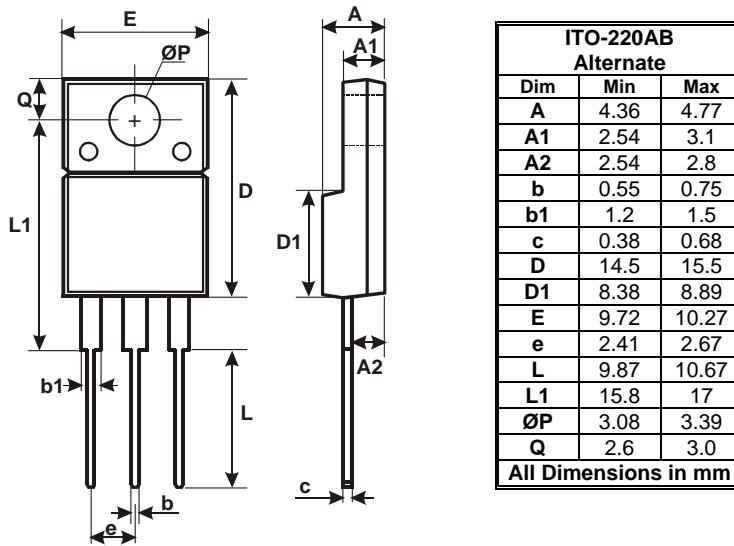
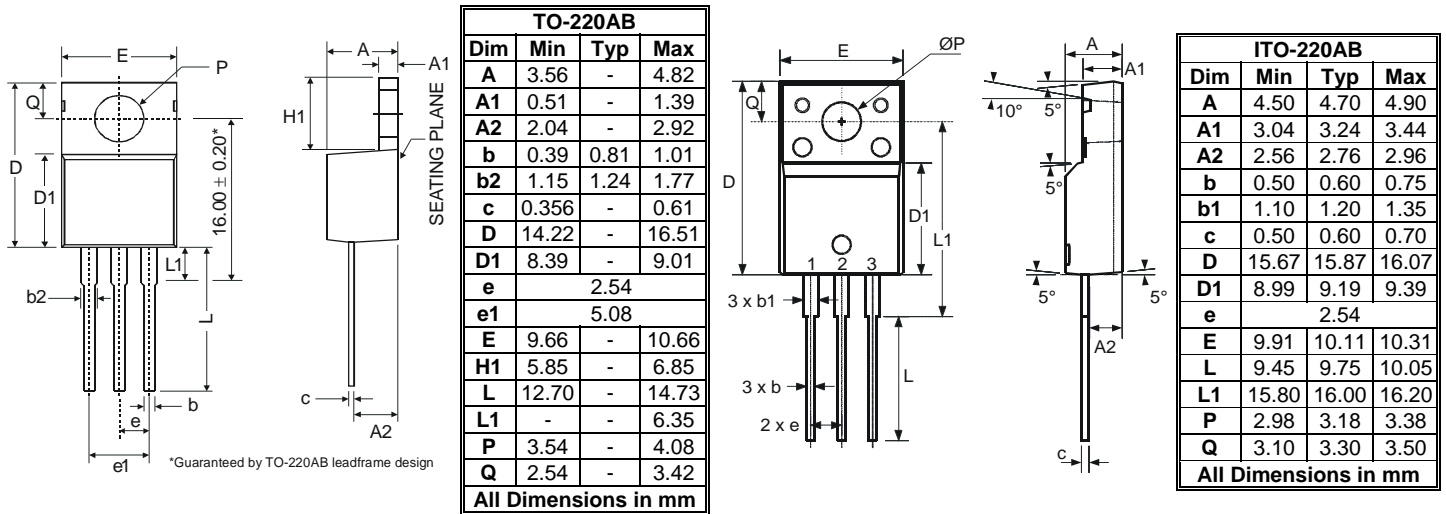


Figure 4: Forward Power Dissipation
