








Fig.1 Input Voltage vs. Output Current





Fig.2 Output Current vs. Input Voltage (OFF Characteristics)


Fig.4 DC Current Gain vs. Output Current



OUTPUT CURRENT : I_o [A]


Fig.3 Output Current vs. Output Voltage










Electrical characteristic curves(T_a=25°C) <For DTr2(PNP)>


Fig.2 Output Current vs. Input Voltage (OFF Characteristics)





Fig.5 Output Voltage vs. Output Current
