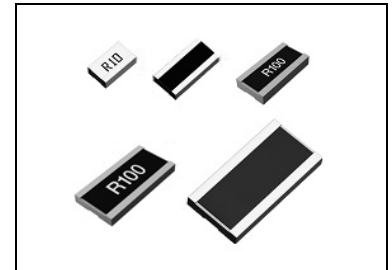

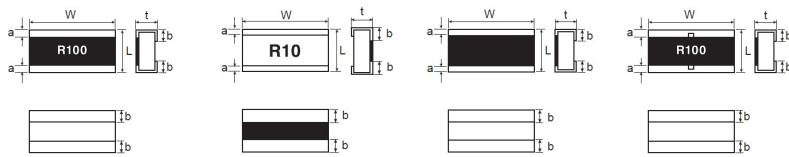

There are four digits used for the calculation number according to IEC code. "L" means decimal point of mΩ unit in case resistance value is 0.01Ω or less. "R" means decimal point of Ω unit in case resistance value is above 0.01Ω

Example :

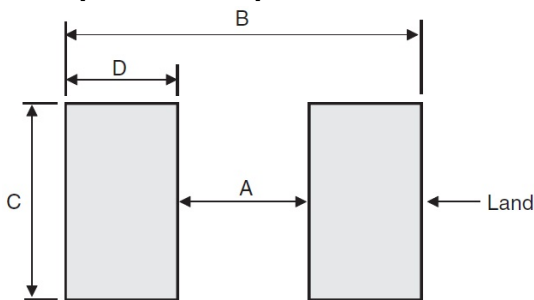
4digits.....10mΩ=10L0, 100mΩ=R100

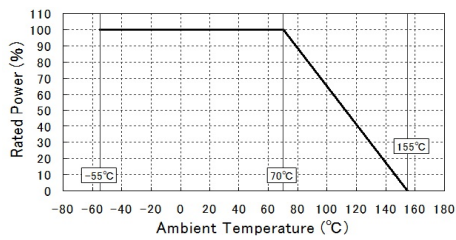


### ●Derating curve

#### ■LHR 18 , LTR 10 / 18 / 50 / 100



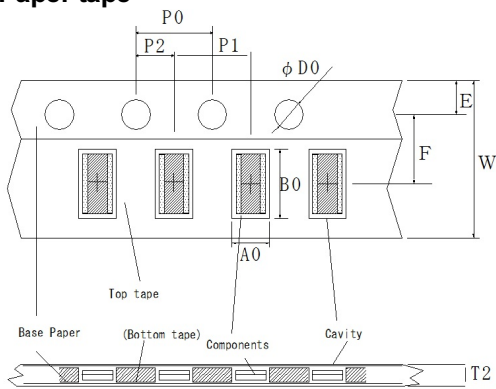

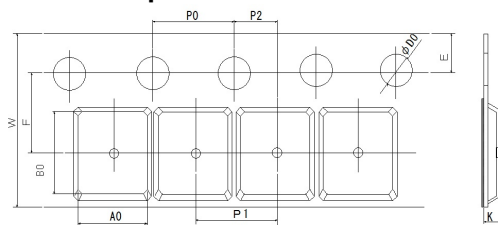

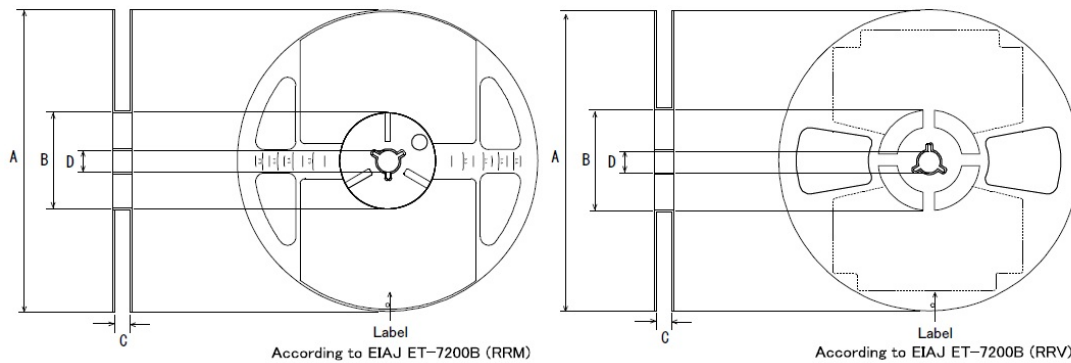
