




F1 Viewing Angle:

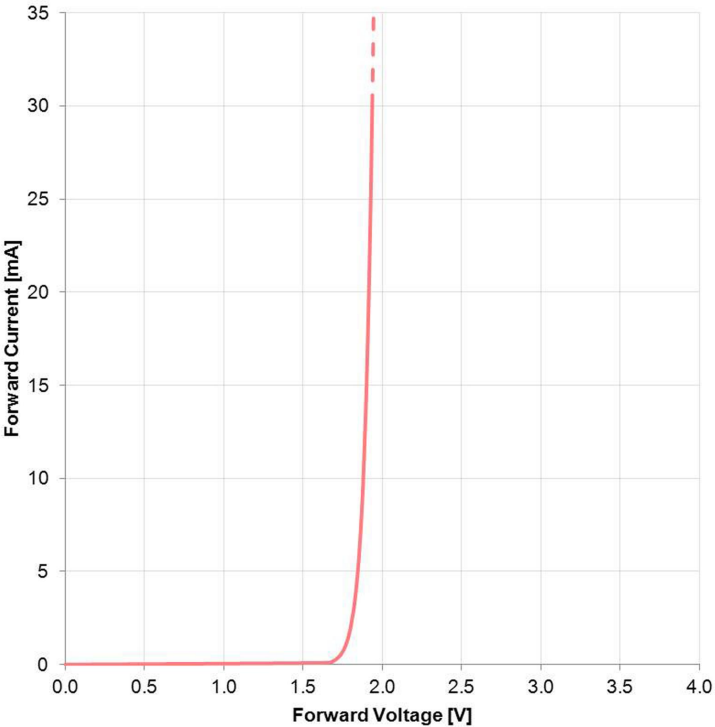

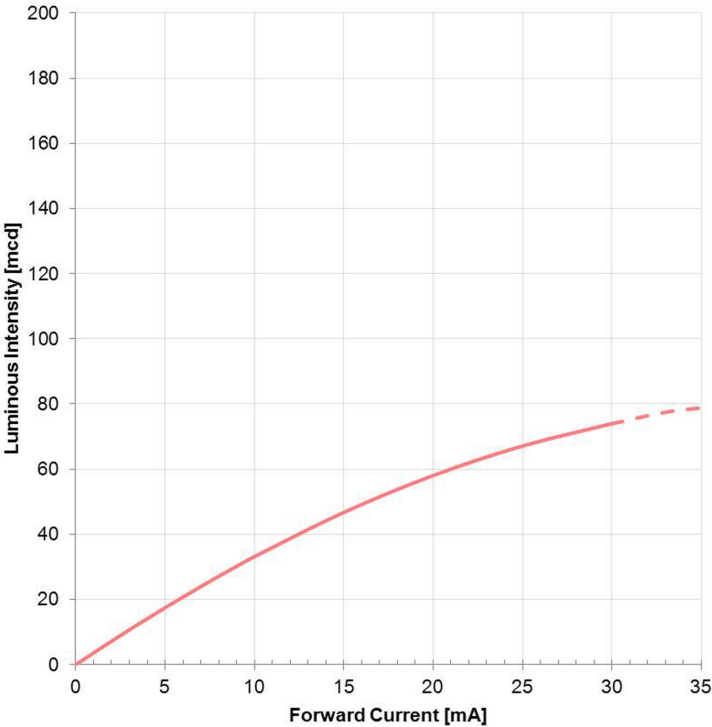

F4 Luminous Intensity vs. Forward Current:




