








Fig. 4 Total Capacitance vs. Reverse Voltage





Figure 6 Operating Temperature Derating




 $t_{1}, {\tt PULSE\ DURATION\ TIME\ (sec)}$ Figure 7 Single Pulse Maximum Power Dissipation


