
# <R> USAGE CAUTIONS

- 1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
- 2. By-pass capacitor of more than 0.1  $\mu$ F is used between Vcc and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Pin 2 (which is an NC<sup>-1</sup> pin) can either be connected directly to the GND pin on the LED side or left open. Unconnected pins should not be used as a bypass for signals or for any other similar purpose because this may degrade the internal noise environment of the device.
  - \*1 NC: Non-connection (No connection)
- 4. Avoid storage at a high temperature and high humidity.


# <R> TYPICAL CHARACTERISTICS (TA = 25°C, unless otherwise specified)




FORWARD CURRENT vs. FORWARD VOLTAGE




THRESHOLD INPUT CURRENT vs. AMBIENT TEMPERATURE




DETECTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE

AMBIENT TEMPERATURE




LOW LEVEL OUTPUT VOLTAGE vs. AMBIENT TEMPERATURE




# PROPAGATION DELAY TIME vs. FORWARD CURRENT



# PROPAGATION DELAY TIME vs. AMBIENT TEMPERATURE




# PROPAGATION DELAY TIME vs. LOAD CAPACITANCE



# PULSE WIDTH DISTORTION vs. FORWARD CURRENT




# PULSE WIDTH DISTORTION vs. AMBIENT TEMPERATURE












# <R> RECOMMENDED MOUNT PAD DIMENSIONS (UNIT: mm)


