Attention

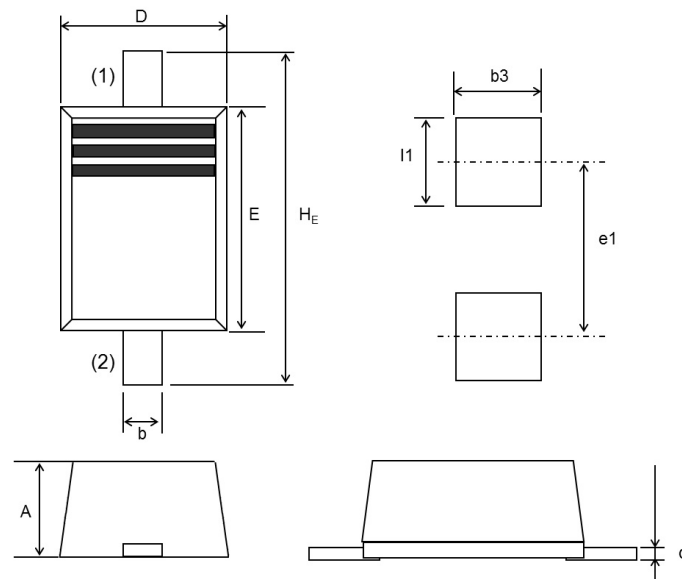

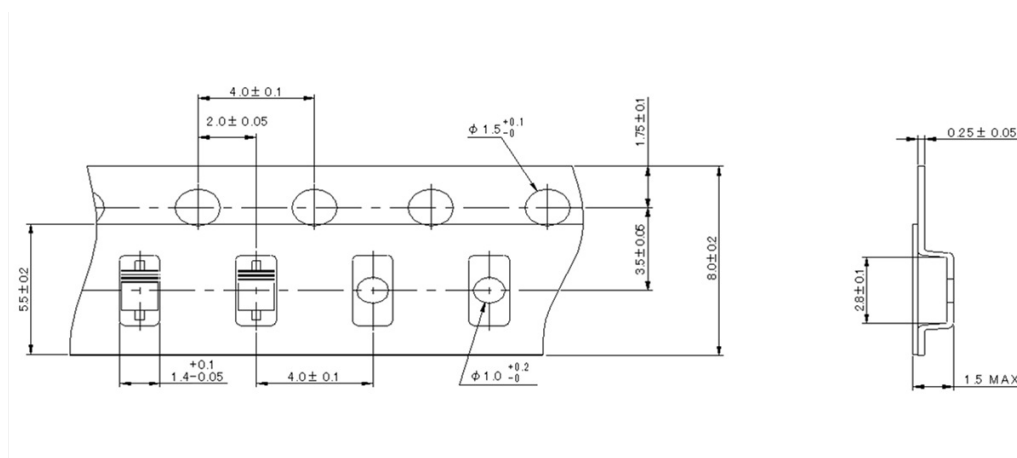
