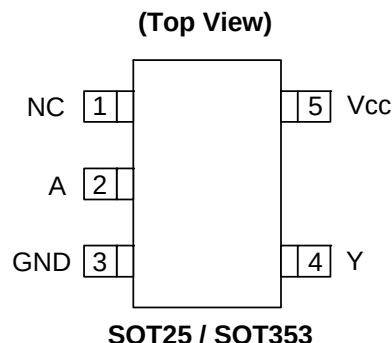


Description

The 74AHC1G04 is a single inverter gate with a standard push-pull output. The device is designed for operation with a power supply range of 2.0V to 5.5V. The gate performs the positive Boolean function:

$$Y = \overline{A}$$

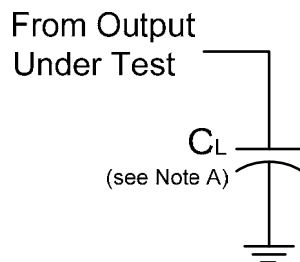

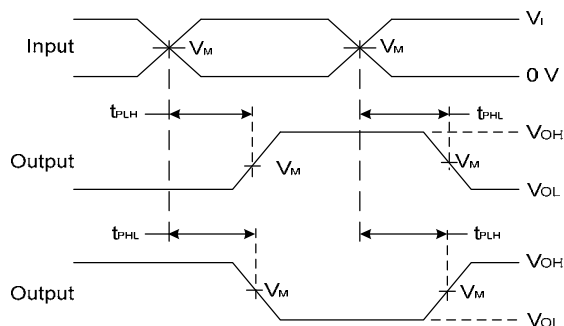

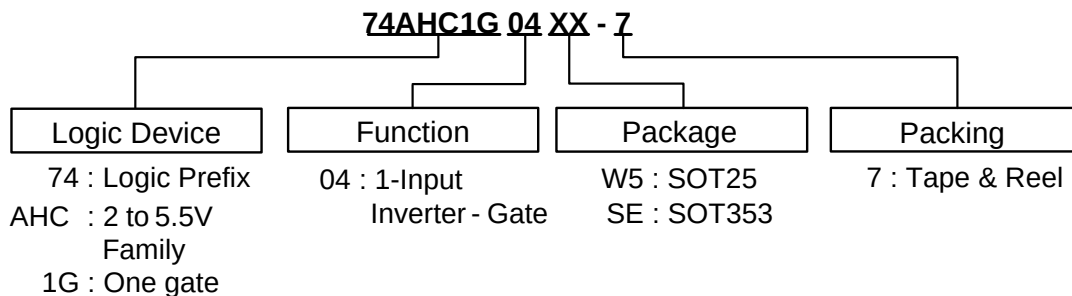


Voltage Waveform Propagation Delay Times Inverting and Non Inverting Outputs

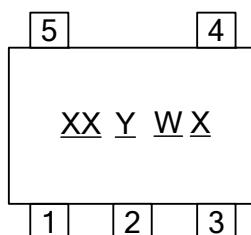

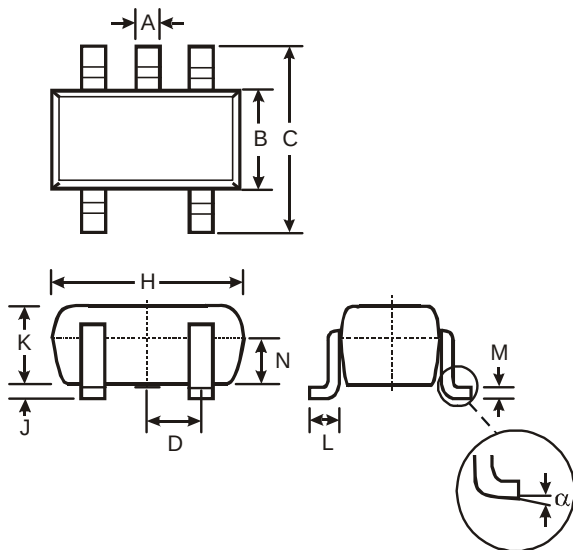

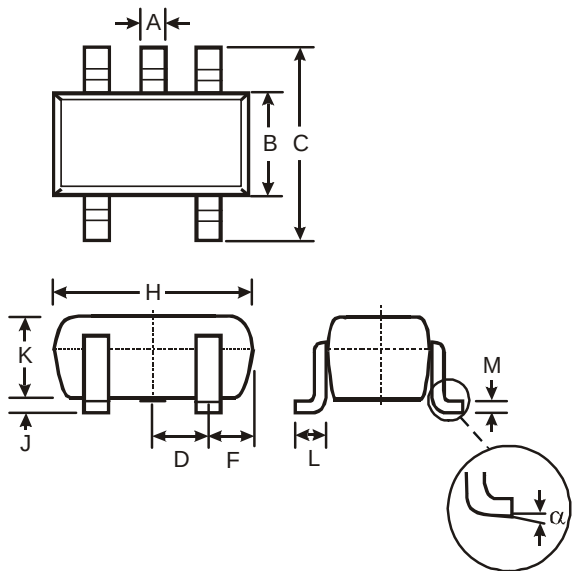
