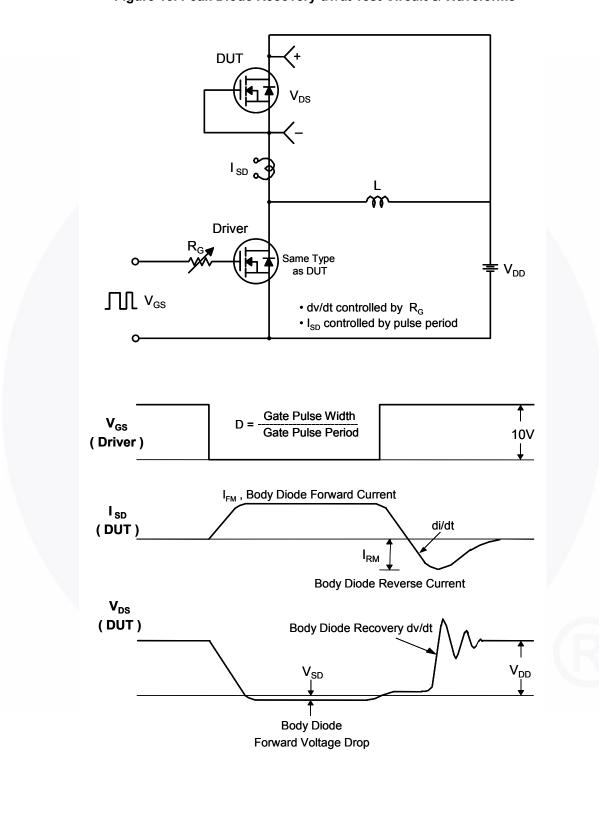
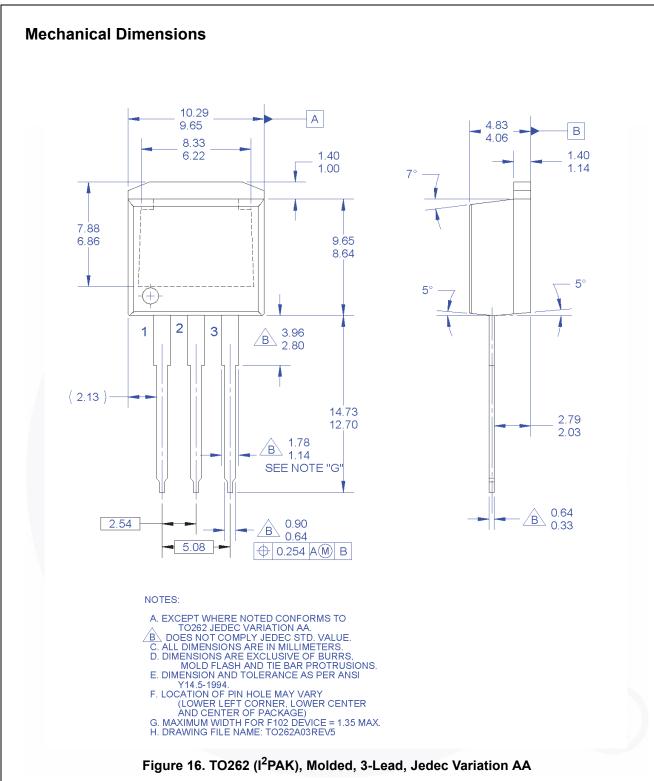


Figure 15. Peak Diode Recovery dv/dt Test Circuit & Waveforms
