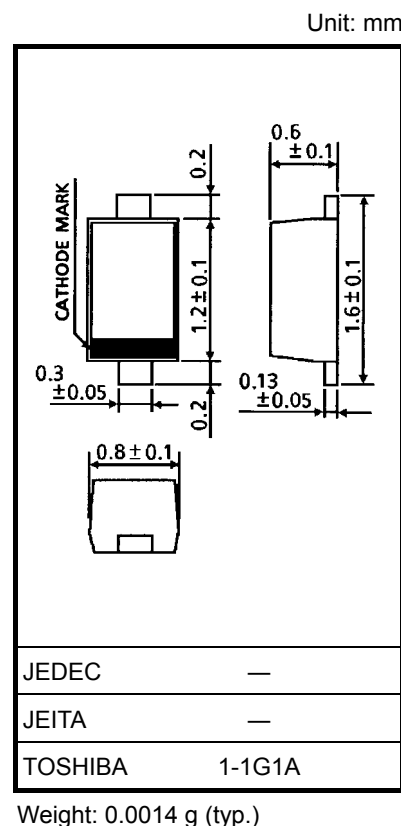
TV Tuning
