The μ PG2411T6R is a GaAs MMIC SPDT (Single Pole Double Throw) switch which was designed for 1 GHz to 8 GHz applications, including dual-band wireless LAN.

This device operates with dual control switching voltages of 1.8 to 3.6 V and can operate at frequencies from 1 GHz to 8 GHz, having the low insertion loss and high isolation.

This device is housed in a 6-pin plastic TSSON (<u>Thin Shrink Small Out-line Non-leaded</u>) and is suitable for highdensity surface mounting.




MOUNTING PAD AND SOLDER MASK LAYOUT DIMENSIONS




